## Benefits to Veterans

### Veteran Friendly Institution

The American Council on Education recognizes CSU's efforts to aid and educate veterans and lists the university as a Veteran Friendly Institution. Universities and colleges are evaluated on criteria including employment services, faculty and staff training, peer mentoring and providing resources to address student needs.

### Transfer Credit

Transfer credit may be awarded for military training, CLEP, DANTES and prior coursework.

### Assistance With Benefits

Your military service makes you eligible for education benefits that can be used at CSU, including the Chapter 33 Post 9/11 GI Bill®, Chapter 30 or Chapter 1606 Montgomery GI Bill®, Veterans Readiness and Employment (VR&E) or Chapter 35 Survivors and Dependents Educational Assistance. ### 1| Apply

Submit your application for admission online by visiting [ColumbiaSouthern.edu/Apply](http://ColumbiaSouthern.edu/Apply) or call an admissions representative. There is no cost to apply.

### 2| Evaluate

Submit transcripts and certifications for a comprehensive academic evaluation. This includes previous high school and college transcripts, CLEP, DANTES, GED official scores, JST or CCAF transcripts and any military certificates that may qualify for college credits.

### 3| Enroll

Your admissions counselor will assist you with the enrollment process once you have reviewed your degree action plan.

### 4| Choose Payment Plan

Military members and veterans can pay tuition via military tuition assistance and the VA Flex Payment Plan. Visit the CSU website for additional payment options.

- » Tuition assistance may be available for military personnel through DANTES.
- » VA requires that you fill out the appropriate paperwork on the Veteran Affairs website to qualify for any payments under the GI Bill®.
